IIF Digital Capital Market Conference: Innovative business models for challenging times

The International Investment Forum (IIF) will take place for the 11th time on April 17, 2024 - with the participation of 20 growth companies from currently sought-after sectors such as defense technology, cryptocurrencies and green energy. Several hundred participants are expected to attend the online event.

The growing threat of terrorism in the year of major events such as the UEFA European Championship or the Olympic Games, the still largely unresolved energy issue, opportunities around cryptocurrencies, or the supply of critical raw materials - investors currently have many unanswered questions. These questions can be addressed to the 20 company representatives who will present live at the 11th edition of the IIF on Wednesday.

In addition to well-known companies from previous editions of the investor conference, such as the motorhome manufacturer Knaus Tabbert AG, the hydrogen specialist Enapter AG, and Carbon Done Right Inc., which specializes in reforestation and the associated CO2 certificates, there will also be presentations from lesser-known companies at the IIF. Newcomers include Liberty Defense Holdings, a company in the security sector that specializes in solutions for public transport, stadiums, and busy inner cities, and Solutiance AG, a platform provider with solutions that are currently in demand in the real estate industry.

"The numerous new companies participating in the 11th edition of the IIF showcase the dynamic nature of the small-cap universe. Often, young companies address issues that have only recently come to the public's attention. This is precisely what makes investing in small-cap stocks so exciting," explains Mario Hose, Managing Director of Apaton Finance GmbH, one of the co-organizers.

In addition to completely new business models, investors will also have the opportunity to evaluate developments and obtain firsthand information on current business from many familiar companies. This is particularly important for capital-intensive growth companies in the technology, biotech and commodities sectors. Sentiment from these sectors is suitable for assessing the future prospects of the real economy. "Young growth companies are the perfect barometer for economic development. Especially in times when financing conditions are gradually loosening, it is exciting to hear what new things companies that regularly present at the IIF have to say," says Manuel Hölzle, CEO of the research firm GBC AG and co-organizer of the IIF.

Company representatives will present at the IIF in 30-minute slots and answer questions live from participants. Analysts from the co-organizer GBC AG moderate the program.
